## WRCQ'S "WOODPECKERS THIRSTY THURSDAY" TICKET GIVEAWAY CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained at the offices of radio station WRCQ ("Station"), owned and operated by Cumulus Broadcasting LLC. or one of its subsidiary companies, 1009 DRAYTON ROAD FAYETTEVILLE, NC 28303, during normal business hours Monday through Friday or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the WRCQ'S "WOODPECKERS THIRSTY THURSDAY" TICKET GIVEAWAY CONTEST (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

**Eligibility.** This Contest is open only to legal U.S. residents 18 years or older, or at the time of entry with a valid Social Security number and who reside in the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, who have not won a prize from the Station in the last **30 days** or a prize valued at \$500 or more in the **90 days**, and whose immediate family members or household members have not won a prize from the Station in the last **30 days** or a prize valued at \$500 or more in the **90 days**. **Void where prohibited by law.** Employees of Cumulus Broadcasting LLC., its parent company, affiliates, related entities and subsidiaries, promotional sponsors, prize providers, advertising agencies, other radio stations serving the Station's DMA, and the immediate family members and household members of all such employees are not eligible to participate. - 2. Contest Period. The Contest will begin at 3:00 pm ET on July 5, 2019 and will run through 6:00 pm ET on July 11, 2019 (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.
- 3. **How to Enter.** To enter:

(i) <u>On-Air</u>: Listen to the Station weekdays from 3:00 pm - 6:00 pm during the afternoon show, during the Contest Period. When the Station plays the "WOODPECKERS THIRSTY THURSDAY" sounder, listeners should call the Station at 910-860-3090. Caller five (5) to the Station, as determined by the Station in its sole discretion, will be entered to win. <u>Time Delay Between Over-the-Air Analog Signal</u> <u>and Internet Broadcast</u>: Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished.

4. **Winner Selection.** Between 3:00 pm – 6:00 pm ET during the afternoon show on **July 5**, **2019** through **July 11**, **2019** Station will select one (1) entry for the Prize in a random drawing from among all valid entries received by Station during the Contest Period. The winning entrant will be contacted during the phone call and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest. Failure to

respond to the initial verification contact within three (3) days of notification will result in disqualification.

Entry Conditions and Release.
