WRCQ'S "HAUNTINGS AT HERITAGE SQUARE" TICKET GIVE AWAY CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained at the offices of radio station WRCQ-FM ("Station"), owned and operated by Cumulus Broadcasting, LLC., 1009 Drayton Road Fayetteville, NC 28303, during normal business hours Monday through Friday or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the WRCQ'S "HAUNTINGS AT HERITAGE SQUARE"GIVE AWAY CONTEST (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility.  - (i) <u>On-Air</u>: Listen to the Station weekdays from 3:00pm 6:00pm ET during the Contest Period. When the Station plays the "cue-to-call", listeners should call the Station at 910-860-3090. Caller five (5) to the Station, as determined by the Station in its sole discretion, will be entered to win. <u>Time Delay Between Over-the-Air Analog Signal and Internet Broadcast</u>: Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished.
- 4. **Winner Selection.** Between 3:00 p.m. 6:00 p.m. ET September 30, 2019 through October 04, 2019 the Station will select one (1) entry for the Prize. Entrants will call the Station at 910-860-3090 when station gives "cue to call", The winning entrant will be contacted during this call and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within three (3) days of notification will result in disqualification.

A winner who returns the affidavit of eligibility and liability/publicity release will be deemed to have accepted the contest prize and thereafter will not be permitted to rescind their acceptance of the prize and/or return the prize.
