## WRCQ "FAYETTEVILLE WOODPECKERS OPENING DAY 2025" TICKET GIVE CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained by contacting radio station WRCQ ("Station"), 1009 Drayton Road, Fayetteville, NC 28303, during available business hours Monday through Friday, on the Station website www.Rock103Rocks.com, by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the WRCQ "FAYETTEVILLE WOODPECKERS OPENING DAY 2025" TICKET GIVE CONTEST (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

- 1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.
  - Eligibility. This Contest is open only to legal U.S. residents excluding Florida or New York residents twenty one (21) years or older, at the time of entry with a valid Social Security number and who reside in the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, who have not won a prize valued at \$500 more in the 90 days, and whose immediate family members or household members have not won a prize from the Station in the last 90 days of a prize valued at \$500 or more in the 90 days. - 2. **Contest Period.** The Contest entry period will begin at **3:00 pm ET on March 31, 2025,** and will **run** through **6:00 pm ET on April 04, 2025** (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.
- 3. **How to Enter and Win.** Listen to the Station during the Contest Period. At or around **3:00 pm ET to 6:00 pm ET** each weekday during contest period when the Station plays sounder (each, the "Sounder"), listeners must call the Station at 910-860-3090. Caller # five (5) to the Station, as determined by the Station in its sole discretion, will be the winner for that Selection Day after providing the Station the winning listener's name and phone number, subject to verification and compliance with these Contest Rules. All entries may be played on the air. *Time Delay Between Over-the-Air Analog Signal and Internet Broadcast:* Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished. Station's decisions as to the administration and operation of the Contest and the selection of the potential winners are final and binding in all matters related to the Contest. Failure to verify winner's eligibility may result in disqualification and forfeiture of the prize. Unclaimed prizes may not be awarded. **LIMIT ONE PRIZE PER PERSON.**

liability/publicity release will be deemed to have accepted the contest prize and thereafter will not be permitted to rescind their acceptance of the prize and/or return the prize.
